## **EXECUTIVE CORNER**

Forty minutes. We now have experienced the Annual Meeting afternoon session adjourning in less than an hour for five consecutive years. As I stated last year, the Association continues to address membership concerns before those issues become problematic, allowing for the shorter afternoon meeting time due to fewer proposals on the agenda. This shorter afternoon session (compared to the "old days" when we had a two-day meeting with over 100 proposals) generates interesting discussion on whether meeting each year is necessary. Both sides have interesting ideas on this subject, including many administrators still appreciating the opportunity to attend the usual meetings of various administrative groups, districts, divisions, committees and classifications, and many of those same administrators valuing the positive social networking that occurs throughout Sunday and Monday. Also, it was noted that the Executive Board meets on Monday afternoon after the conclusion of the Annual Meeting providing an opportunity for schools to address the Board on certain issues without having to travel to Helena. On the other hand, some administrators believe a bi-annual meeting would save districts money and if any major By-Law proposals surfaced they could be addressed at the next Association membership meeting or possibly by online balloting. Also, one administrator suggested having the meeting each year but video streaming the meeting live with the ability for voting delegates to still cast their votes at their home site. He believes this would save districts money and would address travel safety issues caused by bad weather. There is no doubt this subject creates interesting discussions.

No matter the pleasure of the membership regarding the frequency of the membership meeting, this particular Annual Meeting, in my opinion, was one of the best I have ever attended, including my fourteen years in the MHSA office and the many years before as a school administrator. The reason I believe this meeting was one of the best is because of the level of cooperation, compromise and understanding I witnessed at this meeting. Even though we did not have many proposals, two were of major concern for different classifications. The eighth grade proposal was supported by many Class C schools and the reduction of the bricks and mortar requirement was supported by many of the larger school districts. Through that willingness to compromise, both proposals passed.

In other action during the meeting the membership welcomed Karen Underwood, Principal at Laurel High School as the newly elected Class A representative, recognized many deserving MHSA award winners and heard MHSA committee reports. In consideration of a recent Federal Court case involving competitive cheer, the reports and recommendations of the Competitive Cheer Committee and the Additional Female Sport Committee were postponed until more legal directive is obtained.

The 2011 State Speech and Drama Meets, State Wrestling Tournaments and State Swim Meet by all reports, were very successful events. It is hard to believe that district, divisional and state basketball tournaments are just around the corner. There is no doubt this is an exciting time for coaches, players and fans. As I have stated in my February article many times it is important to continue to address at all high school events the expectations of good sporting behaviors by coaches, players and fans.

Crowd control is the responsibility of school administrators, not the game officials. We appreciate your help to guarantee that high school activities are wholesome events for everyone involved and demonstrating that all participants can have fun, as long as everyone stays "centered" on exhibiting good sporting behaviors. Once again, thank you for all the hard work and for what seems like a need for extra vigilance with cheering sections not only during regular season but especially during tournament time.

### **NFHS OUTSTANDING MUSIC EDUCATOR RECOGNITION**

The Annual Meeting provides an opportunity to present NFHS awards to music educators. Each year the National Federation Outstanding Music Educator Awards are presented to individuals across the United States.

Dean Peterson, Choir Director of Missoula Hellgate High School, was awarded the NFHS Music Award for Section 8, which includes Alaska, Idaho, Montana, Oregon, Washington and Wyoming. Dean is first and foremost an educator, although he frequently serves as an adjudicator and as a leader within Montana's music organizations. Currently he serves on the MHSA Music Committee.

## **SERVICE CITATIONS PRESENTED**

The Service Citation is presented in recognition of "significant contributions" made to MHSA programs. The following citations were awarded at the 2011 Annual Meeting in Billings:

Glenn Hageman – Glasgow – Under his leadership, Glenn's current and previous school districts have hosted a variety of district and divisional events in several MHSA sanctioned sports and activities, and he was a long-time member of the Athletic Committee. He served a four-year term on the MHSA Executive Board and completed his Board service as the 2009-2010 Association President.

Darrell Holland – Hamilton – The HHS gym is almost constantly in use for post season tournaments at every level, and Darrell is the ever-present manager for those events. His district has hosted a girls' state basketball tournament every year for more than a decade and has also hosted events in volleyball, wrestling, golf, tennis and speech & drama. In addition, he currently serves on the Master Basketball Scheduling Committee.

Randy Russell – Bozeman – During his tenure as activities director, Bozeman has hosted post season events in football, basketball, wrestling, volleyball, soccer, softball, golf, tennis, track & field, speech and music. Additionally, he hand-scores the State All-Class Wrestling Tournament; he is the AA floor manager for the State All-Class Volleyball Tournament; and he currently chairs the MHSA Swimming Committee.

The James C. Haugen Meritorious Service Award is presented in recognition of "outstanding contributions" made to MHSA programs. It is the highest individual honor presented by the MHSA.

## **MUSIC**

### **PARTICIPATING SCHOOLS MUST BE PART OF DISTRICT MUSIC FESTIVALS**

Our office has received questions regarding district music festival participation. If your school has paid dues for participation in any music program (chorus, band or orchestra), your major performing group(s) must be part of the district music festival. Adjudication of major performing groups is required, not optional.

Also, if students want to participate in solos or small ensembles, they must meet all eligibility requirements, and they must be part of a major performing group and be adjudicated with that group. No student who has not participated in the district festival will be allowed participation in the state festival.

## **TRACK AND FIELD**

### **SAFETY CONSIDERATIONS**

One responsibility of the home meet management or administration is to make all track and field competition areas and competition equipment favorable and safe for all competitors. The expectation of the competition areas and equipment is to have minimal risk or distractions for all competitors. With that in mind, the home meet management or administration must inspect all track and field competition areas and event equipment to make sure it complies with current NFHS Track and Field Rules. The MHSA recommends that this be done before your school's first track and field practice and before each meet.

### **UNDERGARMENT RULE INTERPRETATION**

For the 2010-2011 school year, undergarments displaying seams stitched on the outside of the garment in a visible contrasting color to the undergarment will be illegal. There are undergarments available for purchase by schools and athletes that are not in compliance with the NFHS uniform rules. Coaches must be aware of the rule requirements when purchasing undergarments, and must inform students – who are purchasing their own competitive undergarments – of the rules to avoid non-compliance.

## **POLE VAULTER'S WEIGHT VERIFICATION**

Enclosed is a copy of the pole vaulters' weight verification form that the MHSA requires each school to complete and have on file in the Activities Director's office prior to a pole vaulter's first interscholastic competition (See the 2010-2011 MHSA Handbook #16 on page 180 for a copy of the rule).

### **INVENTORY AND RECONDITIONED HELMETS**

We trust you have checked your existing supply of football helmets and have determined which helmets must be reconditioned so they are completely safe. The MHSA encourages each coach or athletic director when considering reconditioning to contact the manufacturer directly to determine what its policies are regarding reconditioning and warranties. Companies differ in their helmet policies and it is wise to check them out carefully. Please feel free to contact the office for any assistance you may need in contacting reconditioners.

## **RULES CLINICS**

### **SPRING RULES CLINIC ONLINE**

The MHSA/MOA rules clinics for all activities are presented exclusively online. The softball, track and field, tennis and golf clinics will be posted on our main website at [www.mhsa.org](http://www.mhsa.org). Enclosed please find an instruction sheet that details the procedure for accessing the clinics. **March 1** is the planned launch date for the clinics. Head coaches must view the clinics prior to **March 17 for golf and prior to March 25 for softball, track and field and tennis** to receive credit.

All head coaches must view the clinic for their activity in order to meet the clinic requirement. However, all other members of the coaching staff, as well as activities directors, are encouraged to view the clinics. Please note it is required that golf and tennis head coaches view the rules clinic for their sport. Users must complete the registration process at the end of each clinic in order to verify their attendance. ### **RECENT AIM HIGHER WORKSHOPS**

In December, the Aim Higher staff conducted back-to-back workshops. On December 7<sup>th</sup>, Randy Gramm from Choteau and Brian Michelotti conducted a workshop at Malta High School. On December 8<sup>th</sup>, Jill Flynn from Townsend and Brian Michelotti facilitated another workshop at the College of Technology in Great Falls.
