

OFFICE COMMENTS

For the past several years I have taken this opportunity to complain about Montana's spring weather and I believe, as do many others, that we are experiencing our worst spring weather ever. I have decided, instead of whining about the weather, to be positive. We are very fortunate to live in Montana, working in schools that have low levels of violence, working with students who love participating in activities and working hand-in-hand to ensure a good standard of life for our families. We share, as residents of Big Sky Country, a level of cooperation and understanding that is second to none. This level of cooperation and understanding was quite evident at this year's Annual Meeting where compromise was achieved among the classifications to pass a couple major By-Law changes. Our membership's willingness to update and revise our rules and regulations is a credit to our school administrators and their belief that activities are an integral part of their students' high school experience. It is a credit to their vision to review these activity offerings on a continuing basis to provide a rules code that is up to date, efficient and well organized for the benefit of all the thousands of participants in MHSA activities.

The Association, through action by the Executive Board and by the Membership, has brought forth By-Law revisions and rules and regulation changes/additions for the benefit of those who participate in MHSA activities. A summary of those actions includes:

MHSA Annual Meeting Actions

The following proposals were adopted at the 2011 Annual Meeting:

1. The membership approved the following changes to the By-Laws governing student eligibility:

2.1 A student must be enrolled **in twenty hours per week** and in regular attendance **twenty ten** hours per week at the school where the student participates. **Regular attendance is defined as actual physical presence in the building (bricks and mortar).** A home school student is not eligible to participate for an MHSA member school.

Corresponding changes throughout the section were also included, as was a clarification that students with GEDs are not eligible for competition.

2. The membership approved amendments to the eighth grade participation language to expand opportunities for sub-varsity participation.

3. The membership approved the following changes to the By-Laws governing transfers:

A student who has attended high school and resides in a district other than where the student's parent(s) resides, and who subsequently returns to live with the student's parents becomes immediately transfer eligible for varsity competition in the parent's district. This can be applied only one time during the student's career.

Swimming was also added to the transfer provision allowing varsity and sub-varsity team members to compete concurrently but be scored separately.

4. For Classes A, B and C, the football clock stoppage rule was amended to delete requiring the clock to run for a score. Now if the point differential reaches 35 points or more, the clock will still be stopped for a score.

5. For wrestling, the following provision was added:

(7) When three or more schools take part in a double dual meet wrestling competition held in two separate schools/towns that are located less than thirty (30) miles apart and held on the same day, the following provisions apply:

a. One weigh-in will be used for multiple competitions that day.

b. Each dual meet wrestled will be counted as one contested event toward the season limitations.

c. A school not participating in the first dual will be required to follow NFHS rules and weigh-in one hour prior to their dual.

MHSA Executive Board Actions:**Reclassification/Realignment**

- Approved the reclassification of seven schools.
- Approved the realignment of two schools to different districts or conferences for a specific sport.
- Approved the Class B conference realignment.
- Approved the Class A conference realignment.
- Approved three schools for competition in six-player football.
- Approved the Class C six-player football realignment.

Other General Rules and Regulations Items

- Approved requiring Cultural Diversity Training for all MHSA member school coaches and administrators and for all MOA officials. The format for the training, including locations etc. will be announced in the near future.
- Approved a mandate that assistant and school approved volunteer coaches must also view the MHSA mandatory on-line rules clinic for their respective sports. The requirement for head coaches to view the clinic was previously established.
- Approved that tournament managers for MHSA post-season events must complete the tournament manager online workshop for that sport once every five years. The requirement is sport specific.
- Approved the following additions to the Crowd Control Section of the MHSA Handbook:
 - a) Special attention must be given to the supervision of student cheering sections **including having an administrator present near the vicinity of the student cheering section for home and post season contests to assist with crowd control** (pending two-week notice).
 - b) At outdoor contests **the use of electronic and air amplified devices by spectators is prohibited. At all outdoor contests bands will not be allowed to play during "live ball."**
- Approved the policy regarding lighting for player introductions and other related matters (pending two-week notice). [A copy of this policy is available by contacting the MHSA office.]
- Approved amending the language for state tournament tickets prices in having the Executive Board establish those prices. In addition the Board will establish all post season playoffs and state championship football games ticket prices. (There was no change to established ticket prices).
- Approved providing wrist bands to be worn by qualifying schools' band members for admission to state tournament events.

Basketball

Approved a combined boys' and girls' basketball state tournament format for Class B. This format will be utilized beginning in 2012-2013.

Softball

Approved the following addition for ending games at invitational tournaments: The game can be called if there is five minutes or less before the maximum time limit **or officials should not start a new inning after 1 hour and 20 minutes of play, except if a tie exists where NFHS Softball Rules for tiebreaking would be followed.**

Golf

- Approved language to clarify the maximum dates of competition allowed for each individual golfer.
- Approved clarifying that qualifying scores for the State C Meets **must be recorded on a regulation golf course (9 hole course – minimum of a par 35; 18 hole course – minimum of a par 70)** (pending two-week notice).
- Approved clarifying that at the Class AA State Golf Tournament, no practice round will be allowed on the tournament course the day before the state tournament begins or at any time during the seven day period preceding the opening of the tournament including all other provisions

per General Rules for Post Season Golf Meets, # 12. (per existing Class AA policy and pending two-week notice).

IMPORTANT ANNOUNCEMENTS

Spirit

Approved miscellaneous additions and revisions to the Spirit Section of the MHSAA Handbook (pending two-week notice for comment). [A list of these specific changes is available by contacting the MHSAA office.]

Soccer

Approved the Class A Soccer Play Off Bracket format and revisions to the Class AA State Soccer Tournament brackets.

Speech and Drama Items

As recommended by the MFEA, various amendments to speech, debate and drama rules were approved, including specific changes to topics, sources, original material, entries and the progress of individual events. There were significant amendments to eligibility rules for forensic participants that were precipitated by the recently amended eligibility By-Laws for athletics. [A list of these specific changes is available by contacting the MHSAA office.]

Music Items

Several amendments were made to the music rules and regulations, including a change in the All-State audition fee that will facilitate online auditions. As with speech and drama, additional amendments include significant changes to eligibility rules for music participants that were precipitated by the recently amended eligibility By-Laws for athletics. [A list of these specific changes is available by contacting the MHSAA office.]

Track and Field and Cross Country

- Approved the following provision regarding the state cross country meet: ***“Each MHSAA school will be required to share proportionally the cost of the state cross country meet by a paying a fee per qualifying participant. This fee will be set by the MHSAA Executive Board prior to the event, in relation to the projected expenses bid by the successful site when the state sites are determined.”***
- Approved requiring that athletes meet a qualifying time in at least one regular season cross country meet prior to participation in the State Cross Country Meet.
- Approved implementing qualifying standards for the 2011-2012 Class A State Track and Field Meet (pending two-week notice). The standards and procedures will be similar to Class AA, except the Board approved Class A to use hand-held adjusted times and seeding methods appropriate for Class A. [A list of these specific changes is available by contacting the MHSAA office.]
- Approved allowing multiple track and field divisions competing at the same meet site to begin at 12:00 p.m. on the first day of the meet.
- Approved specific requirements for throwing events warm-ups.

Wrestling

The Board approved, for Class B-C Wrestling, to award two additional team trophies for Class C schools. Class B-C wrestlers will continue to compete together for individual medalist honors. Trophies are presently awarded to the top three teams in Class B-C and also to the Class C team with the most points. With this change first, second and third place trophies will be awarded to Class B schools and first, second and third place trophies will be awarded to Class C schools.

As you can tell by the above summary, 2010-11 was an extremely busy year. The MHSAA member schools, the MHSAA Board and the MHSAA staff are continuing to work diligently to review and to revise how we operate our great Association. Confucius once said, “Success depends upon previous preparation, and without such preparation there is sure to be failure.” There is no doubt in my mind that the Association has been well prepared leading to the successes we have been experiencing collectively.

Once again, on behalf of the MHSAA Executive Board and MHSAA Staff I want to thank you for your support and for your willingness to provide your comments and suggestions during this year. The MHSAA office staff is here to serve and if you have any questions, comments or concerns please let us know. Have a great remainder of your school year (hopefully with warmer and drier weather) and I hope you have a very relaxing summer.

AIM HIGHER PROGRAM

Another year of AIM Higher has been completed and once again we had a very successful year. The AIM Higher Program continues to include sessions on leadership, mentoring, team captain training, hazing awareness, drug prevention and sportsmanship. We also were able to incorporate more activities into the workshop this year, which makes the day more enjoyable for everyone involved. We feel many students were able to return to their schools and create positive change. This year a record 619 students participated in eight workshops throughout the state marking the 22nd year of this successful program. In fact in the past six years, 44 workshops have been conducted with 3,072 participants taking part in the leadership activities.

We particularly owe a debt of gratitude to Butte High School, Malta High School, Manhattan High School, St Labre High School and Sidney High School who allowed us to use their facilities and resources for workshops in 2010-11. SPIRIT

ELIGIBILITY FOR SPIRIT

Each year the MHSA office receives several questions asking whether cheerleaders and/or dance team members are required to follow MHSA Eligibility rules such as age rule, transfer rule, specialized camp rule, fundraising rule etc.

Spirit groups are exempt from MHSA eligibility rules because the groups are not considered an MHSA sanctioned sport. The groups are, however, required to follow the rules as set forth by the National Federation as well as rules found in the Spirit Section of the MHSA Handbook.

Note: Please be advised that local school districts have the authority to apply eligibility standards to spirit groups if they so choose.

Membership in the Montana Coaches Association is offered to high school spirit coaches. Just a few of the important benefits that could be realized as a member of the MCA include: reduced admission to the annual MCA Clinic in Great Falls, free admission to all regular season high school and college games in Montana, enrollment in a million dollar coaches liability policy which covers classroom teaching as well as camp coaching, and receipt of four newsletters which relate to coaching. TRACK & FIELD

STATE TRACK & FIELD MEETS

If you would like to volunteer and help at the State A/C Track Meet, please contact Jim Baldwin at Alberton High School.

Please remind your track and field coaches to read the State Meet Policies and Procedures found on pages 7-10 of the 2010-11 State Track and Field Procedures Manual, so they can continue to be familiar with policies and procedures at this year's State Track and Field Meets.

Javelin Certification: There seem to be questions about javelin certification for track and field meets. Ron Johnson, a javelin expert, suggests performing the following tests to certify javelins for track and field meets. Please share this information with your Head Track and Field Coaches and other appropriate personnel.

1. Test the weight of the javelin.
2. Test the overall length of the javelin.
3. Check the balance point of the javelin.
4. Look to see if the javelin has an IAAF certification sticker.
5. Test the diameter of the tail portion of the javelin. To test the diameter of the tail section you must use calipers that have English or metric measurements and do the following:
 - a) Find the **balance point** of the javelin.
 - b) With the calipers measure the diameter of the shaft at the thickest point, front of grip;
 - c) Calculate 90% of that measurement;
 - d) With a tape measure, measure from the **balance point** to the end of the tail of the javelin;
 - e) Go to a point $\frac{1}{2}$ the total distance from the **balance point** to the tail;
 - f) Using the caliper measure the diameter at that point – it must be no less than 90% of the diameter measurement of front of grip.

On pages 46-47 of the NFHS Track and Field Rule Book you can find the IAAF javelin specifications.
