IMPORTANT ANNOUNCEMENTS

CULTURAL DIVERSITY MANDATORY WORKSHOPS SCHEDULED

Effective in 2011-12, the MHSА Executive Board approved requiring Cultural Diversity Training for the following MHSА/MOА personnel:

- An onsite administrator and/or athletic/activities director from each member school
- All MHSА sanctioned sports head coaches
- All MOА officials

It is important to note that at least one school administrator and/or athletic/activities director from each school must attend and also that each head coach of the eleven sanctioned MHSА sports must also be in attendance at one of the scheduled presentations.

The purpose of the training is to help administrators, coaches and officials enhance their knowledge and self-awareness of diversity issues in MHSА-sanctioned athletics and activities to prevent cultural miscommunications, disconnects or conflicts.

The schedule, which provides twenty-seven (27) opportunities to attend, has been posted. A schedule of workshop locations, sites and times is attached.

TROPHIES AND AWARDS REMINDER

In response to questions received in the MHSА office concerning conference trophies, the following information from the MHSА Handbook is offered:

1. Conference trophies are given in football only (they are considered district or divisional trophies).
2. In other sports, if a conference would like to award a trophy (first place only) for their conference champion it must be ordered through the MHSА office and must be paid for by the conference. The MHSА office staff does not automatically order conference trophies because some conferences don't choose to award them.
3. Trophies that are awarded by MHSА rule will be awarded to both schools if the activity is cooperatively sponsored, but the MHSА office will need to know which school was presented the trophy at the tournament. Also, if there is a co-op conference champion or if a conference has co-champions the conference still needs to order those trophies through MHSА and pay for both.

BASKETBALL

PLAYERS STARTING A GAME

NFHS Basketball rules state: Each team consists of five players, one of whom is the captain. A team must begin the game with **five** players (unless the MHSAA has given **only** a sub-varsity team permission to start a game with four players), but if it has no substitutes to replace disqualified or injured players, it must continue with fewer than five. When there is only one player participating for a team, the team shall forfeit the game, unless the referee believes that team has an opportunity to win the game. **Coaches: remember that by MHSAA rules, the Association prohibits students of member schools from playing in a preliminary contest and starting in the varsity contest on the same day. Coaches must ensure that this MHSAA rule is not violated. Because this is a MHSAA rule, MOA Basketball officials will follow NFHS rules requiring a varsity team to start with five players even if the some of the players have played in a sub-varsity contest.**

WHO CAN PRACTICE?

By MHSAA Rules, only students who meet all MHSAA eligibility requirements (enrollment, age, semesters, academics, physical examinations etc.) are eligible to practice with and participate on member school teams. Exceptions: 1) students who are eligible in every way except academics may participate in practice if the school allows, and 2) students approved by the Executive Director to participate as an eighth grader.

PREGAME WARM-UPS

Teams entering the gymnasium prior to the contest should not run through the area occupied by the opposing team or under the basket where the opponents are warming up. Teams should only enter, jog, or warm-up on their own half of the court. If during pre-game or halftime warm-ups one team leaves the floor, the other team is NOT to use the entire floor. Teams are to warm-up on their half of the court only. **Gatherings intended to motivate a team after the warm-up period, during, or following introductions and post-game celebrations should be performed in the area directly in front of the team bench.** The center court area of the court should not be used for those gatherings. Once again, teams must stay on their side of the court. Coaches - you are in complete control of helping eliminate these things from happening. When planning your warm-up, be sure you and your team are abiding by this point of emphasis.

DIMMED LIGHTING DURING CONTEST INTRODUCTIONS

The MHSAA Board approved the policy regarding lighting for player introductions and other related matters. MHSAA Allowable Procedures for varied and/or dimmed lighting during contest introductions:

Regular Season

- For any indoor MHSAA athletic contest, facility lights may be dimmed or partially extinguished only during introductions and only within the following guidelines:
- If lights are dimmed or modified during introductions, enough light must remain to ensure the safety of all occupants in the facility, specifically for the purposes of maintaining crowd control and guaranteeing that aisles, stairways and exits are visible.
- If partial lighting sections above the area of competition are fully extinguished, the lighting sections above the fan areas must remain on, and aisles, stairways and exits must remain visible.
- The use of spotlights is allowed provided they are used appropriately and do not delay the start of the game.
- Home and visiting teams must be introduced in the same manner, and gender equity standards must be met in showcasing introductions in this manner.
- All local fire and public safety codes must be followed.

Post Season

For all indoor post season events (playoffs and tournaments), full facility lighting will remain on throughout introductions and between contests if applicable.

WRESTLING

WRESTLING COACH REGISTRATION FOR FLOOR ACCESS AT STATE WRESTLING TOURNAMENTS

For the past few years the MHSAA has implemented a different procedure for issuing coaches' passes for the MHSAA State Wrestling Tournament. Again this year, schools are required to submit a list of their certified coaches that will represent their school at the state wrestling tournament. In an effort to make the wrestling area less congested and to afford a better environment for those participating, the MHSAA will print wrist bands with the coaches' names and schools, which will allow these individuals access to the floor. WRESTLING REMINDER

Remember the growth allowance that was added to the *MHSAA Handbook* two years ago. A one-pound growth allowance will be added to each weight class on January 1 and an additional one-pound growth allowance will be added to each weight class on February 1. STATE WRESTLING TOURNAMENT SCHEDULE

Last year, the state wrestling tournaments were assigned to separate locations due to the reconstruction of MetraPark in Billings. The Class AA State Tournament was held at CM Russell High School (Great Falls), the Class A State Tournament was held at Butte Civic Center and Class B-C State Tournament was held at Hamilton High School. All three facilities did an outstanding job hosting the events. Thanks to those communities and volunteers for hosting and making those events a memorable experience for everyone involved.

This year, we are back to the All-Class format and the State All Class Wrestling Tournament will be held at MetraPark in Billings on February 10-11, 2012. We look forward to seeing everybody under the same roof for another All-Class Tournament.

Wrestling coaches and administrators of wrestling programs are reminded that student athletes will weigh-in the first day of the State Wrestling Tournament. There will be no weigh-ins on Thursday before the tournament, but MetraPark will be open for practice from 3:00 p.m. to 6:00 p.m. on that day. Scales will be available for weight checks.

The schedule has been posted on the wrestling page of the MHSAA website and will be sent to coaches and principals prior to the state tournament.

SPIRIT

SPIRIT RULES REMINDERS

The MHSAA believes it is extremely important to reduce the risk of injury due to cheerleading participation by increasing safety awareness.

All provisions of the National Federation Spirit Rules Book as well as regulations listed in the Spirit Section of the MHSAA Handbook shall be in effect for all spirit team activities including practices, games, performances and competitions. Violations of these regulations are subject to penalties as outlined in Article VIII, Section (2) of the MHSAA By-Laws. Listed below are four rules which are being highlighted this month.

- The Association prohibits spirit teams from participating in any spirit related activity (practices, games, performances and/or competitions) on a Sunday.
- Spirit participants must remain outside the playing area during a 30-second or less time-out in a basketball game.
- A participant in a full head and/or body costume (mascot) must not spot, stunt or tumble, except for a legal forward roll or cartwheel.
- Spirit participants must wear athletic shoes at all times.
